OCTOBER LONG WEEKEND MARKET INDUCTION 2021

NB: This Market Day is subject to change pending Covid Restrictions or State Lockdown regulations at the time of the event. If the event is unable to proceed, stallholder fees will be refunded.

WORK HEALTH AND SAFETY

This is a site specific induction for stallholders of the Gloucester Spring Market Day to be held on Saturday 2nd October, 2021. The induction will cover the hazards, control measures and site safety rules that apply to each area of the market site. You are encouraged to keep all of the information provided during this induction. These procedures, which form part of the Market Charter and cover the hazards, control measures and site safety rules that apply to each area of the Market site.

SITE ACCESS

There are two vehicle access points to the park area on the southern side of the suspension bridge at Billabong Park. All vehicles entering the site will observe a 10 km/hr speed limit at all.

Access point 1 - is via Denison Street, immediately to the west of the amenity block

Access point 2 – is via Billabong Lane car park area 2, to the east of the GCM site.

(Unless the Suspension Bridge is repaired and reopened prior to the October long weekend, the event will take place on the Southern side of the park only. This Site Induction is working on the safe assumption that the bridge will not be opened by 2nd October)

EMERGENCY EVACUATION AND ASSEMBLY AREA

In the event of an emergency, as a visitor you are required to strictly follow the directions given by the Market Coordinator. You will be notified of any requirement to evacuate by the Market Coordinator raising the alarm and directing you to evacuate. You should move to the Muster Points unless instructed to do otherwise. In the event that an emergency vehicle is required to enter the site, the Market Coordinator, will direct a person to the vehicle entry point to assist with directing the emergency vehicle to the required location. The Emergency Muster Points are outlined in the map at the end of this induction.

FIRST AID & FIRE EXTINGUISHER

A First Aid Kit and Fire Extinguisher will be on hand to the right of the centre stage in a clearly marked box.

FUEL AND CHEMICAL STORES

If you are bringing any potentially dangerous chemicals such as fuels and oils on to the Market, you must notify the Market Coordinator and provide a copy of a **product Material Safety Data Sheet (MSDS)**.

IDENTIFYING HAZARDS AND RISK ASSESSMENT

A risk assessment template has been prepared for this site and is available on the Gloucester Community Market Facebook page and website. Alternatively, you should consult the Market Coordinator if you need a copy of this document. Stallholders are required to complete a risk assessment of their stall and to provide a copy of this to the Market Coordinator to keep on file.

VEHICLE MOVEMENTS

Other than Emergency Service Vehicles, only Stallholders may bring vehicles onto the site and must obey a 10 km/hr speed limit at all times. It is suggested that where reversing cannot be avoided, another person spots for pedestrians. Vehicles from stalls located in the centre of the park must be offsite by 7.45am or earlier if possible to ensure safe access back through the completed set-up. No vehicles may move within the site during market opening times.

DRINKING WATER

Fresh drinking water is available at the front of the amenity block located on Denison Street.

CANOPIES, TENTS AND ROPES

Stallholders are to secure sites against wind, rain and storm events. In extreme weather conditions, the Market Coordinator may decide to cancel the market for that particular day. Any ropes are to have high visibility ribbons attached so as to ensure they are visible. Weights are to be used to secure gazebos in place.

TOILET FACILITIES

Stallholders are to use the public toilets on Denison Street.

POWER LINES AND ELECTRICAL EQUIPMENT

There are no identified overhead power lines on this site; however there may be powered sites that access power from the toilet or BBQ blocks for food vendors. All shelters, equipment, fittings or materials used at the Market are subject to a safety inspection. The outward sign of electrical compliance with the Act will be an Electrical Test Tag to AS3760, it is the responsibility of all stallholders using power to have all the electrical leads and equipment Tagged and Tested. All leads and cables must be secured in a manner so as not to create trip hazards. If any shelters, equipment, fittings or materials are deemed not to comply with OH&S regulations, or are considered to be unsafe for any reason, they shall be removed from the site at the expense of the Stallholder.

INJURY

Any injury regardless of how minor must be reported to the Market Coordinator who will assist you with first aid and record the details of the injury.

INFORMATION TO BE RETAINED BY THE STALLHOLDER

You are encouraged to retain this information as it provides details that you may wish to refer to at a later date. MAPS - EMERGENCY MUSTER POINTS

The Gloucester Spring Market Day's Emergency Evacuation Areas on the south end of the Billabong Park are the same as the Gloucester Farmers Market, as shown in the map below:-



A third Muster Point is located on Boundary Street that runs parallel to the main west entrance to the Billabong Park as shown in the map below:-
